The meeting was called to order at 5:15 by Chairman, Jim Sheehan. The minutes of November 18, 2019 were accepted by Jake Greaney seconded by Jim Sheehan. Jake and Jim were in favor. Jeremy was not in attendance for that meeting.

Jim Sheehan questioned where the money was coming from to pay the crew to plow for the town. Colin stated that it will come from the snow and ice fund.

Bill Daley attended the Board's meeting. The Board discussed how he would get the town's sewer to his project. He stated that he has not talked to Chesterton regarding their hooking up. Bill Daley did ask if he would have to do all the overlay for the streets? Jim Sheehan stated that he will require a definitive plan with drops, inverts etc and he felt there needs to be a 4% slope. A set of construction plans he will have to maintain the roads; the size of the equipment he is using where his going site elevations for each house. There needs to be a 12" to Center Street then go to an 8" from there. Colin Stokes will talk to National Grid regarding the easement on their property. Jim Sheehan suggested that Colin talk to Glenn Smith regarding this issue.

#### RATE INCREASE PUBLIC HEARING

The Board and staff went to the Great Room to have the public hearing for the rate increase. Chairman, Jim Sheehan explained on video the rate increases. There was no one in attendance. Jim Sheehan motioned to close the public hearing at 6:05 PM.

Once back at the regular meeting Jim Sheehan motioned to raise the water rates: Motioned to remove the discount on all tiers except the minimum rate. Increase water rates 10% in all areas to be applied to the April 2020 bill (reading begins December 18, 2019) with an additional 10% again in July 2020. Also make the Conservation rate unified with only one rate using the residential rate. The sewer rates will remain the same at this time. Seconded by Jake Greaney, all in favor.

# Water Rates In July 2020

Min. \$65.91 to \$72.50 1201 + from \$6.02 to \$6.62 3000+ Conservation Rate: \$11.24 to \$12.36
